Assignor further authorizes the Commissioner of Patents and Trademarks of the United States to record the rights to the Trademark as the property of the Assignee.

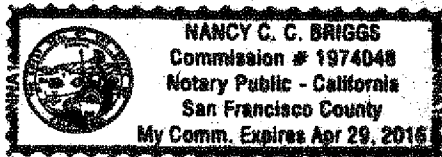
