RELEASE OF SECURITY INTEREST IN TRADEMARKS

Agrees that any power of attorney or similar rights granted by the Debtor to the Secured Party under the Security Agreement is terminated; and

Hereby expressly authorizes Nixon Peabody LLP, as counsel to the Debtor's current lender, to file this release with the USPTO and requests that the USPTO note and record the existence of the release hereby given.

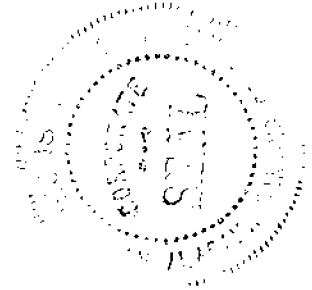



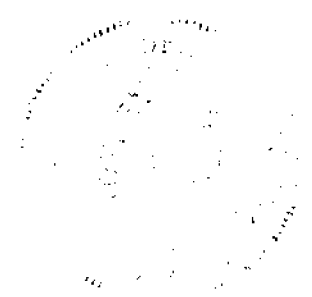
