RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release of Trademark Security Agreement ("Release") is made this 24th day of March, 2015, by Paul Cutler (the "Secured Party") in favor of AM Conservation Group, Inc., a New Jersey corporation (the "Grantor"). All capitalized terms used herein without definition shall have the meanings given to such terms in that certain Trademark Security Agreement, dated November 24, 2010, and the Amendment to Security Agreement, dated January 20, 2011, by and between Secured Party and Grantor (collectively, "Security Agreement").

WHEREAS, reference is made to the Security Agreement by Grantor in favor of Secured Party, recorded with the United States Patent and Trademark Office on January 20, 2011 at Reel/Frame: 4457/0836;

WHEREAS, in connection with the Security Agreement, Grantor granted to Secured Party, a security interest in, among other things, the Trademark ("Trademark Collateral"), including without limitation to the Trademark set forth in Schedule A attached hereto;

WHEREAS, pursuant to a pay-off letter dated May 17, 2013 Secured Party released all liens on the assets of Grantor and agreed to file all financing agreements, notes, assignments, deeds of trust, mortgages, security agreements, guaranties, instruments and all other documents of any nature;

WHEREAS, Secured Party has the requisite power and authority to release and discharge its security interest in and to the Trademark Collateral; and

WHEREAS, Secured Party desires to release and discharge its security interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Secured Party hereby releases and remits to Grantor any and all right, title and interest in and to its security interest in and to the Trademark Collateral, including without limitation the Trademark identified in Schedule A, and reassigns any and all interest it may have in such Trademark Collateral to Grantor. The Secured Party hereby authorizes the Grantor or Grantor's authorized representative to record this Release with the United States Patent and Trademark Office.
