**PARTIAL TERMINATION OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

WHEREAS, 21CT, INC., a Delaware corporation whose address is 6011 W. Courtyard Drive, Building 5, Suite 300, Austin, Texas 78746 (the "Grantor"), entered into that certain Patent and Trademark Security Agreement effective as of June 28, 2013 (the "Security Agreement"), between the Grantor and CADENCE BANK, a national banking association (the "Secured Party"), under the Credit Agreement (the "Credit Agreement") dated effective June 28, 2013, by and between Secured Party and Grantor; and

Releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party in and to the Released Patents and Trademarks pursuant to any and all of the Security Documents, as well as any and all liens and other security interests (if any) held by the Secured Party in and to any of the Released Patents and Trademarks, all without recourse or representation or warranty, express or implied; and

2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given with respect to the Released Patents and Trademarks.

It is expressly understood and agreed that this Partial Termination of Security Interest in Patents and Trademarks in no way operates to release or discharge the liens, security interests, right, title and interest of Secured Party in and to any other patents, patent applications, trademarks or trademark applications pursuant to any of the Security Documents, but is only intended to release the Released Patents and Trademarks.


