NOTICE OF ASSIGNMENT OF TRADEMARK AND ACCOMPANYING GOODWILL

- (iv) the resulting right to recover damages and profits for past, present or future infringements or unauthorized use thereof, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives as fully and entirely as the same would have been held and enjoyed by Mr. Sanders if he had not died

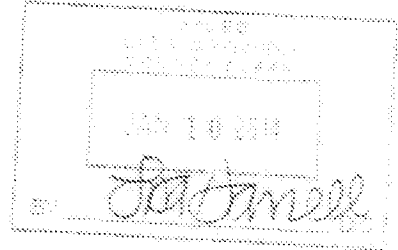

ORDER


Based upon an examination of the sworn Petition, and the testimony of the Petitioner, Timothy Morrow Sanders, II, on January 10, 2014, the Court finds the following:

- A. The decedent died at his residence located at 4711 Sulpher Springs Road, Murfreesboro, Tennessee on December 30, 2013, at 63 years of age.
- B. The decedent was a resident of Rutherford County, Tennessee at the time of his death.
- C. The decedent died without a will.
- D. The Petitioner is the person with the highest right to serve as personal representative.
- E. Since the Petitioner is the only heir at law, bond, inventory, and accountings should be waived.

Based upon these findings, the Court orders the following:

- 1. The Estate of Timothy Morrow Sanders be opened.
- 2. After administering the oath to the Petitioner, Letters of Administration will be issued to Timothy Morrow Sanders, II.
- 3. Bond shall be waived pursuant to *T.C.A. § 30-1-201(a)(1)*.
- 4. Inventory and accountings shall be waived pursuant to *T.C.A. §30-2-301 and T.C.A. §30-2-601*.
- 5. Notice to creditors be issued and the Department of Revenue be notified as required by Tennessee Code Annotated §§ 30-2-306 and 67-8-406 respectively.
- 6. The Administrator shall be permitted to carry on the decedent's business, Prismic Light International, for a period of nine (9) months pursuant to *T.C.A. §30-2-322*.

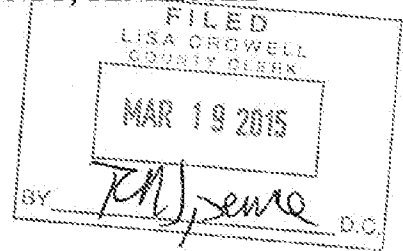


