NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. The Secured Party hereby, in reliance of the certifications made by the Company pursuant to that certain Notification, Certification and Lien Release Request, dated March [20], 2015 concerning the sale of the Released Marks, releases and reassigns to the Company any and all liens, security interests, right, title and interest of the Secured Party in and to the Released Marks granted under the Security Agreement, and all of the goodwill associated thereto, without recourse or representation or warranty, express or implied, of any kind; and

2. The Secured Party hereby authorizes and requests the Commissioner of Trademarks of the United States of America to note and record the existence of the termination hereby given.

3. This termination is applicable only and solely with respect to the Released Marks and to no other collateral arising under the Security Agreement (the "Retained Collateral"). The Secured Party retains all security interests, liens, rights, titles and interests pledged and granted to the Secured Party under the Security Agreement with respect to all such Retained Collateral. The Secured Party's security interest, liens, rights, titles and interests in such Retained Collateral remains in full force and in effect, and this termination shall not, and shall not be deemed to, impair, interrupt or otherwise modify the Secured Party's interest in such Retained Collateral in any respect.
