NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of April 24, 2014, is made by Wells Fargo Bank, National Association, as collateral agent (in such capacity, the "Agent"), in favor of Kwikset Corporation, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of December 17, 2012 (the "Security Agreement"), by the Grantor and the Agent, recorded in the United States Patent and Trademark Office at Reel 4939, Frame 0209, the Grantor assigned and granted to the Agent a security interest in Grantor's right, title and interest in and to the trademarks listed on Exhibit A hereto (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks, the applications, registrations and records related to the Trademarks and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Released Assets"); and

WHEREAS, Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Assets;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release. The Agent has been instructed by the Grantor to execute and deliver this Release. The Agent hereby relinquishes, releases and discharges its security interest in the Released Assets and all right, title and interest of the Grantor in the Released Assets are hereby reassigned by the Agent to the Grantor.

2. Further Assurances. The Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the United States Patent and Trademark Office. The Agent further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or their agents or designees) reasonably request in writing (at the Grantor's sole cost and expense) in order to confirm this Release and the Grantor's right, title and interest in, to and under the Released Assets.

3. Governing Law. This Release shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement.
