## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("**Release**"), is made and effective as of this 20 day of March, 2015 and made by U.S. BANK NATIONAL ASSOCIATION (the "**Lender**").

WHEREAS, DreamHammer Incorporated (the "**Borrower**") entered into a certain Business Loan Agreement dated as of October 30, 2007, as subsequently amended (collectively, the "**Loan Agreement**"), with California National Bank. Lender is the present holder of the Loan Agreement and the loan which is the subject of the Loan Agreement;

WHEREAS, in connection with the Loan Agreement, DreamHammer Products LLC, a Delaware limited liability company ("**Grantor**") entered into that certain Trademark Security Agreement dated as of September 24, 2012 in favor of Lender (the "**Security Agreement**");

WHEREAS, pursuant the Security Agreement, Grantor pledged and granted to the Secured Party a security interest in and to all of the right, title and interest of such Grantor in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 4878/Frame 0291 on October 10, 2012; and

WHEREAS, the Grantor has requested that Lender enter into this Release in order to accomplish and evidence the release and reassignment of any and all right, title and interest the Lender may have in the Trademark Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby states as follows:

1. Definition. The term "Copyright Collateral", as used herein, shall mean all of each Grantor's right, title and interest of every kind and nature as of the date hereof in all Trademarks and all Goodwill associated with the Trademarks, as those terms are defined in the Security Agreement (collectively, the "**Trademark Collateral**") including, without limitation, all of the following:

(a) any and all trademarks, service marks, trade names, brand names, logos, and trade dress, whether registered or unregistered, including the trademark registrations

and applications set forth in Schedule 1 hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof;

(b) all tangible embodiments of the foregoing;

(c) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(d) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(e) any and all claims and causes of action arising before, on or after the date hereof for infringement of any such Trademarks or for unfair competition regarding the same.

2. Release of Security Interest. Lender, its successors, legal representatives and assigns, terminates, releases and discharges its security interest in and to the Trademark Collateral, and all other right, title, and interest in and to the Trademark Collateral and reassigns to the Grantor any and all such right, title and interest that it may have in the Trademark Collateral.

3. Further Assurances. Lender agrees to execute, acknowledge, procure and deliver to Grantor any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably requests in order to confirm, effectuate or record this Release and Grantor's (or its assignee's) right, title and interest in and to the Trademark Collateral provided that all fees and costs incurred by Lender in complying with any such request made by Grantor (or any assignee) under this Paragraph 3, including, without limitation, all attorneys' fees and costs, are timely paid by Grantor.

4. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of California, without giving effect to any choice or conflict of law provision or rule (whether of the State of California or any other jurisdiction).
