RELEASE OF TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest ("Release") is given on this 30th day of March 2015, by U.S. BANK NATIONAL ASSOCIATION, for itself and as administrative agent (in such capacity, the "Grantee"), to BENDON, INC. (formerly known as Bendon Publishing International, Inc., the "Grantor"), as follows:

WHEREAS, on February 29, 2012, the Grantor and the Grantee entered into a Pledge and Security Agreement, which required the parties to enter into the Security Agreement (as defined below);

WHEREAS, on February 29, 2012, the Grantor and the Grantee entered into a Confirmatory Grant of Security Interest in United States Trademarks ("Security Agreement");

WHEREAS, pursuant to said Security Agreement, the Grantor granted to the Grantee, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under its United States trademarks, including but not limited to the trademarks listed on the attached Schedule A, together with all proceeds of such trademarks and all causes of action arising prior to or after the date thereof for infringement of such trademarks or unfair competition regarding the same (the "Trademarks");

WHEREAS, said Security Agreement was recorded in the United States Patent & Trademark Office on February 29, 2012, at reel/frame 4726/0326;

WHEREAS, the Grantor has satisfied the terms of the Pledge and Security Agreement (including all conditions for release), and the Grantee wishes to release its security interest in the Trademarks, including those listed on Schedule A and retransfer and reassign to the Grantor without recourse all of the Grantee's right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby unconditionally terminates the Security Agreement and releases any security interest, right or other interest it may have in the Trademarks, including those listed on Schedule A, and hereby reassigns any and all right, title and interest it may have in and to the Trademarks without recourse to the Grantor, together with the goodwill of the business symbolized thereby.
