WHEREAS the Assignor is the owner of the trademarks set forth on the attached Exhibit A together with the goodwill of the business associated therewith and symbolized thereby and all rights thereto, including but not limited to, all common law rights, if any, causes of action, all interests, claims and rights for damages, profits and other awards by reason of any past infringement, dilution, misappropriation or other violation thereof, and the right to sue therefor (collectively the "Marks"); and

WHEREAS the Assignor wishes to transfer and assign all the rights in said Marks to the Assignee who accepts this transfer;

NOW THEREFORE, in consideration of the sum of \$2.00 and other good and valuable considerations now paid by the Assignee to the Assignor, the receipt whereof the Assignor hereby acknowledges;

1. Assignor hereby assigns unto the Assignee all of its rights, title and interest in the Marks.

2. The Assignor agrees to, at the request of the Assignee or any its successors or permitted assigns, including any person that acquires all or substantially all of the assets of the Assignee relating to its hotel management and franchising business (the "Permitted Successors and Assigns"), take, or cause to be taken, all additional actions and to execute, or cause to be executed, any additional documents, conveyances, transfers, assumptions and other assurances which may be required to transfer all of the Assignor's rights, title and interest in and to the Marks to the Assignee or any of the Permitted Successor and Assigns.

3. The Assignor hereby authorizes the relevant governmental Intellectual Property Offices to transfer the Marks to Assignee, as assignee and owner thereof.

4. The Assignor acknowledges and agrees that it has the power and authority to assign the Marks to the Assignee.

5. This Agreement may be executed in any number of counterparts and all of these counterparts shall for all purposes constitute one agreement binding on the parties and be deemed originals for all purposes notwithstanding that all parties are not signatory to the same counterpart.

6. This Agreement shall be governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein, without reference to its principles of conflicts of law.
