RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 8, 2014 in favor of Key Health Group, Inc., a Delaware corporation ("Grantor") by Convergent Capital Partners II, L.P., (the "Secured Party"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, Grantor executed that certain Security Agreement, dated April 29, 2011 (as the same may be amended, modified or supplemented from time to time, the "Security Agreement") in favor of the Secured Party;

WHEREAS, pursuant to the Security Agreement, Grantor granted to Secured Party a security interest in and lien on all of its right, title and interest in, to and under certain intellectual property and, in connection therewith, entered into that certain Notice of Security Interest in U.S. Trademarks (the "Notice") for the purpose of recording such security interest with respect to the trademarks of Grantor, including those items set forth on Schedule A hereto (the "Trademark Collateral"), with the United States Patent and Trademark Office;

WHEREAS, the Notice was recorded with the United States Patent and Trademark Office on May 20, 2011 at Reel 4545, Frame 0115; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby (i) terminates the Notice, (ii) terminates, cancels and releases any and all security interests and liens it has against the Trademark Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademark Collateral.

Secured Party shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.


