RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of March 31, 2015 ("Effective Date"), by **WELLS FARGO CAPITAL FINANCE, LLC**, a Delaware limited liability company ("WFCF"), in its capacity as agent and security trustee for the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (in such capacity, together with its successors and assigns in such capacity, "Grantee"), in favor of **MARQUETTE TRANSPORTATION COMPANY HOLDINGS, LLC**, a Delaware limited liability company ("Parent"), **MARQUETTE TRANSPORTATION COMPANY, LLC**, a Delaware limited liability company ("Marquette"), **MARQUETTE TRANSPORTATION COMPANY GULF-INLAND, LLC**, a Delaware limited liability company ("MTC Gulf-Inland"), **MARQUETTE TRANSPORTATION COMPANY OFFSHORE, LLC**, a Delaware limited liability company ("MTC Offshore"), **EMS TOWING, LLC**, a Delaware limited liability company ("EMS Towing"), **BLUEGRASS MARINE, LLC**, a Delaware limited liability company, **CHERAMIE, LLC**, a Delaware limited liability company, **EAST COAST MARINE TOWING, LLC**, a Delaware limited liability company, **MARQUETTE TRANSPORTATION FINANCE CORPORATION**, a Delaware corporation, and **LMR FREIGHT, LLC**, a Delaware limited liability company (collectively, jointly and severally, the "Grantors" and, each individually, a "Grantor").

WHEREAS, reference is made to that certain Credit Agreement dated as of January 19, 2010, by and among the lenders party thereto, Parent, Marquette, MTC Gulf-Inland, MTC Offshore and EMS Towing (as amended by that certain Amendment Number One to Credit Agreement and to Security Agreement dated as of September 30, 2011, as further amended by that certain Amendment Number Two to Credit Agreement and to Security Agreement dated as of March 7, 2013, as further amended by that certain Amendment Number Three to Credit Agreement dated as of April 21, 2014, and as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of January 19, 2010, by and among the Grantors and Grantee (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office on January 20, 2010 at Reel 004134, Frame 0066, the Grantors granted to Grantee a security interest in all of the Grantors' right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

WHEREAS, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registration listed on **Schedule 1** hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:


1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to the Grantors all right, title and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
