**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of April 1, 2015, is made by GENERAL ELECTRIC CAPITAL CORPORATION ("**GE Capital**"), as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, the "**Administrative Agent**") for the Lenders (as defined in the Credit Agreement referred to below). Terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement, as applicable.

WHEREAS, in connection with that certain Credit Agreement, dated as of April 4, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among Townsquare Radio, LLC (the "**Borrower**"), Townsquare Radio Holdings, LLC (the "**Holdings**"), the Lenders and GE Capital, as Administrative Agent for the Lenders, the Lenders have severally agreed to provide certain loans to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, each Guarantor has agreed, pursuant to a Guaranty and Security Agreement in favor of the Administrative Agent (the "**Guaranty and Security Agreement**") to guarantee the Obligations of the Borrower;

WHEREAS, in connection with the Credit Agreement, Guaranty and Security Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Loan Parties granted security interests in certain intellectual property owned by the Loan Parties, including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and


WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

NOW THEREFORE, the Administrative Agent hereby releases, without representation, recourse or warranty whatsoever, all of their security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Intellectual Property Collateral to the Loan Parties. The Administrative Agent agrees, at the expense of the Loan Parties, to cooperate with the Loan Parties and to provide the Loan Parties with the information and additional authorization reasonably required to effect the release of the Administrative Agent's security interests in the Intellectual Property Collateral.
