RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST

THIS RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST (this "Release") is given on April 1, 2015, by SUNTRUST BANK, as Administrative Agent (the "Administrative Agent"), to THE E.W.
