TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made this 31st day of March, 2015 (the “Release Date”) by Wells Fargo Bank, National Association (“Wells Fargo”), as collateral agent for the Secured Parties (in such capacity, together with its successors in such capacity, the “Collateral Agent”).

WHEREAS, Rock-It Cargo USA LLC, a Delaware limited liability company (the “Grantor”) has entered into that certain Credit Agreement, dated as of February 28, 2013 with the Collateral Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the “Credit Agreement”);

WHEREAS, the Grantor has entered into that certain Security Agreement, dated as of February 28, 2013 in favor of the Collateral Agent, for the benefit of the Secured Parties (as at any time prior to the date hereof amended, supplemented or otherwise modified, the “Security Agreement”);

WHEREAS, in connection with the Security Agreement, the Grantor has entered into that certain Grant of Security Interest Trademarks, dated as of February 28, 2013 with the Collateral Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the “Trademark Security Agreement”), pursuant to which the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Grantor in and to the Trademarks identified in Exhibit A attached hereto and made a part hereof, together with the goodwill associated therewith or symbolized thereby and all other assets, rights, interests that uniquely reflect or embody such goodwill, and all proceeds thereof (the “Trademark Collateral”), to secure the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise of all of the Secured Obligations (as defined in the Security Agreement) of the Grantor.

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on April 29, 2013 at Reel 5015 Frame 0980;

WHEREAS, the Grantor has paid all outstanding amounts currently owing under the Credit Agreement and the other financing documents executed in connection therewith and has requested that the Collateral Agent release its security interest in the Trademark Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Collateral Agent hereby irrevocably and forever terminates, releases and discharges any and all security interests in the Trademark Collateral granted by the Grantor under the Trademark Security Agreement and the Security Agreement.

2. Recordation of Release. The Collateral Agent understands and agrees that this Release may be recorded by or for the Grantor with the USPTO.

3. Further Actions. The Collateral Agent further agrees to execute any other documents and take any further action reasonably necessary in the United States that the Grantor may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be prepared by counsel to the Grantor and the cost and expense of such documents and actions shall be borne solely by the Grantor.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Credit Agreement and/or the Security Agreement, as applicable.
