ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, in consideration of the payment by ASSIGNEE to ASSIGNOR of the sum of Ten Dollars (\$10.00), and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR has agreed to assign and does hereby assign to ASSIGNEE all right, title and interest to said TRADEMARKS, and any registrations thereof, and in and to any renewals and extensions that may be granted thereon, together with the goodwill of the business in connection with which the TRADEMARKS are used and which is symbolized by the TRADEMARKS, all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the TRADEMARKS, including without limitation, damages and payment for past or future infringements and misappropriations of the TRADEMARKS, and all rights to sue for past, present and future infringements or misappropriations of the TRADEMARKS.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the TRADEMARKS.
