**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of April 2, 2015, from MORGAN STANLEY SENIOR FUNDING, INC., in its capacity as Collateral Agent (the "Agent") to ALVOGEN, INC., a Delaware corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Collateral Agreement, dated as of May 23, 2013, in favor of the Agent (the "Collateral Agreement"), Grantor granted a security interest (the "Security Interest") to the Agent in certain collateral, including the trademark registrations set forth on Schedule I (the "Trademarks") hereto;

WHEREAS, pursuant to that certain Trademark Collateral Agreement dated as of May 23, 2013, among the Agent and Grantor (the "Trademark Agreement"), Grantor, by reference to the Collateral Agreement, reaffirmed the grant of the Security Interest to the Agent specifically in certain Trademark Collateral (as that term is defined in the Trademark Agreement);

WHEREAS, the Trademark Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 23, 2013 at Reel 5034 and Frame 0230.


WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the payment and performance in full of the Obligations, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Agreement or the Collateral Agreement.
2. Release of Security Interest. The Agent hereby, without representation or warranty of any kind, terminates, releases and discharges its Security Interest in the Trademark Collateral, including the Trademarks, all goodwill of the business associated with the Trademarks, and any right, title or interest of the Agent in such Trademark Collateral arising under the Trademark Agreement or Collateral Agreement shall hereby cease and become void.
3. Further Assurances. Upon the reasonable request of the Grantor, and at the Grantor's sole cost and expense, the Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
