RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release") is made as of April 2, 2015 ("Effective Date") by and between **TRISUN HEALTHCARE, LLC**, a Texas limited liability company, located at 1703 West Fifth Street, Suite 800 Austin, TX 78703 (the "Grantor"; and together with any Person (as defined in the Loan Agreement referenced below) from time to time joined as a borrower party to the Loan Agreement, individually, a "Borrower" and collectively, the "Borrowers"), in favor of **CIT FINANCE LLC**, a Delaware limited liability company, as agent (the "Agent"), in connection with that certain Loan and Security Agreement dated as of December 2, 2013 among the Borrowers, Agent and the lenders from time to time party thereto (the "Lenders") (as amended, restated, supplemented or modified from time to time, the "Loan Agreement"). Capitalized terms not otherwise defined herein are being used herein as defined in the Loan Agreement.

WHEREAS, pursuant to the Loan Agreement the Grantor pledged and granted to the Agent for the benefit of the Lenders a continuing security interest in all intellectual property constituting Collateral, including the trademarks listed on Schedule A hereto (the "Trademarks"), as set forth in that certain Grant of Security Inteest in Trademark Rights, dated as of December 2, 2013 by Grantor in favor of Agent (as amended, restated, supplemented, or otherwise modified from time to time, the "Agreement");

WHEREAS, an executed copy of the Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on March 31, 2014, at Reel 5248, Frame 0001; and

WHEREAS, Agent has agreed to release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby:

1. releases any and all liens, security interests, right, title and interest of Agent granted pursuant to the Agreement in the trademarks of Grantor without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to Agent under the Agreement is terminated; and
3. authorizes and requests that the USPTO note and record the existence of the release hereby given.
