TRADEMARK AND DOMAIN NAME ASSIGNMENT

This Trademark and Domain Name Assignment (this "Assignment") is made as of February 27, 2015 (the "Effective Date") by and among IO DATA CENTERS LLC, a Delaware limited liability company ("IO" or "Assignor") and BASELAYER TECHNOLOGY, LLC, a Delaware limited liability company ("BASELAYER" or "Assignee").

WHEREAS, the transactions contemplated by this Assignment are being effected in connection with certain reorganization transactions of the parties pursuant to which, among other things, the members of IO are contributing their membership interests in IO for membership interests in Innovation Holdings, LLC, a Delaware limited liability company ("IH") and thereafter, IO will distribute its membership interests in BASELAYER to IH.

NOW THEREFORE, in consideration of the promises and the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Grant and Assignment of Marks. Effective as of the Effective Date, Assignor does hereby sell, transfer, convey, assign and deliver to Assignee all of Assignor's right, title, and interest in and to those certain trademarks, service marks and trade names and pending applications listed on Exhibit A attached hereto (collectively, the "Marks"), together with the goodwill of Assignor's business and common law trademark rights pertaining thereto, the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made; together with all claims for damages by reason of past infringements of the Marks, along with the right to sue for and collect such damages for the use and benefit of Assignee and Assignee's successors, assigns and other legal representatives. Assignor does hereby further sell, transfer, convey, assign and deliver to Assignee all of its right, title and interest in and to the Marks in any country foreign to the United States of America.

2. Assignment of Domain Names. Effective as of the Effective Date, Assignor does hereby sell, transfer, convey, assign and deliver to Assignee all of Assignor's right, title, and interest in and to the internet domain names listed on Exhibit B attached hereto (collectively, the "Domain Names").

3. Further Assurances. Each party will, without additional consideration, take such further actions and execute promptly such further documents as are necessary to effect and record the above assignments, including any actions or documents required by the applicable registrar to document the transfer herein or as may be necessary to protect, secure and vest good, valid and marketable title and related rights to the Marks and Domain Names in Assignee.

4. Recording of Assignments. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, any Secretary of State or equivalent governing authority, and any officer of any country or countries foreign to the United States, whose duty it is to issue the Marks to record Assignee's right, title and interest in and to


the Marks with the United States Patent and Trademark Office or such similar governing body in accordance with the terms of this Assignment.


