TERMINATION OF SECURITY AGREEMENT

WHEREAS, Cambridge Boat Club, a Massachusetts corporation with a principal place of business at 2 Gerry's Landing, Cambridge, Massachusetts 02138 ("GRANTOR"), is the owner of record of the trademark and trademark registrations listed on Exhibit "A" attached hereto (collectively referred herein to as the "Trademark"); and

WHEREAS, GRANTOR is the owner of additional trademarks and trademark collateral (collectively referred to herein as "Trademark Collateral") as more specifically described in a certain Trademark Collateral Assignment and Security Agreement dated December 3, 1998 ("Security Agreement") between GRANTOR and Cambridge Trust Company, having a mailing address of 1336 Massachusetts Avenue, Cambridge, Massachusetts 02138 ("SECURED PARTY"); and

WHEREAS, SECURED PARTY caused a true and correct copy of the Security Agreement to be recorded in the United States Patent and Trademark Office on December 10, 1998, at Reel 1829 Frame 0822; and

WHEREAS, SECURED PARTY desires to release its security interest in the Trademark and Trademark Collateral and to terminate the Security Agreement, nunc pro tunc, effective as of January 24, 2014;

NOW, THEREFORE, for good valuable consideration, the SECURED PARTY:

1. hereby unconditionally and irrevocably releases and reassigns any and all liens, security interests, rights, title, and interest of SECURED PARTY in and to the Trademark and Trademark Collateral pursuant to the Security Agreement, without recourse or representation, express or implied;

2. hereby authorizes GRANTOR to request that the Commissioner for Trademarks record the termination of the Security Agreement on the records of the United States Patent and Trademark Office and authorizes GRANTOR to execute the recordation request form and do all other things necessary to effect the recordation.
