**TRADEMARK ASSIGNMENT**

**THIS ASSIGNMENT** is made as of the 7<sup>th</sup> day of April 2015, by and between Thomas Ziller, citizen of the Federal Republic of Germany, with an address of Dorfstrasse 20, 40699 Erkrath, Germany ("Assignor") on the one hand, and Ziller GmbH & Co. KG, a German Limited Liability Company with an address of Reisholzstrasse 15, 40721 Hilden, Germany ("Assignee") on the other hand.

**WHEREAS**, Assignor owns the U.S. trademark NILOS & Design of Circle under Registration Number 615,791 therefor, including the good will associated with the foregoing, (collectively, the "Trademark");



**WHEREAS**, Assignor wishes to sell and assign, and Assignee wishes to purchase and assume, the Trademark;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby severally acknowledged, the parties agree as follows:

1. Assignor hereby sells, transfers, and assigns to Assignee all right, title and interest in, to, and under the Trademark, including the registration therefor, and the goodwill associated therewith.
2. Assignor further grants to Assignee the right to bring suit for and recover damages and all other relief for all past infringements of the Trademark.
3. Assignor agrees to execute such further documents and take such further steps as may be reasonably requested by Assignee in order to confirm and perfect its rights in the Trademark.
4. Assignor agrees to execute all documents, assist in all proceedings and take any reasonable further steps as Assignee may deem necessary (at the sole cost and expense of the Assignee) to effectuate the transfer of the Trademark to Assignee, or the perfection, registration, or recordation of the rights of the Assignee thereto, as Assignee may reasonably deem appropriate. If Assignor does not, within fifteen (15) days of presentment, return the requested executed documents, then Assignee is hereby granted a limited power of attorney to execute all such documents on behalf of Assignor. This power of attorney is coupled with an interest and is irrevocable.
