TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of April 7, 2015, is by BANK OF AMERICA, N.A., a national banking association, in its capacity as the collateral agent for the secured parties (the "**Bank**"), in favor of KINGS SUPER MARKETS, INC., a New Jersey corporation and BALDUCCI'S HOLDINGS LLC, a Delaware limited liability company (collectively, the "**Grantors**").

WITNESSETH:

WHEREAS, the Grantors entered into that certain Second Amended Trademark Security Agreement, dated May 9, 2013, in favor of the Bank (as amended, restated, supplemented or otherwise modified from time to time to the date hereof, the "**Trademark Security Agreement**"); and

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, the Grantors granted to the Bank a continuing security interest in all of the Grantors' rights, title and interests in and to certain collateral, including without limitation, the trademark registrations and trademark applications set forth on Schedule A attached hereto, together with the goodwill associated therewith (collectively, the "**Trademark Collateral**"); and

WHEREAS, the Trademark Security Agreement was recorded with United States Patent and Trademark Office on September 26, 2013 at Reel 5117 and Frame 0845; and

WHEREAS, the Bank now desires to terminate and release its security interest in and liens upon the Trademark Collateral; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

(a) the Bank hereby terminates, reassigns, relinquishes, releases and discharges any and all security interests and liens it has in or against the Trademark Collateral, without recourse or representation or warranty, express or implied;

(b) if and to the extent that the Bank has acquired any right, title or interest to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to the Grantor, without recourse or representation or warranty, express or implied; and


(c) the Bank agrees to make filings with the United States Patent and Trademark Office and other necessary filings to evidence the release and termination of the Bank's security interests in the Trademark Collateral as reasonably requested by the Grantor, in each case at the sole cost and expense of the Grantor.

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE BANK'S SUCCESSORS AND PERMITTED ASSIGNS.
