1. Assignor and Assignee expressly agree that the assignment filed on December 4, 2014, was intended to vest all rights, title and interest in and to the Mark, including the goodwill of the business symbolized thereby, in Assignee.
2. Assignor hereby assigns to Assignee all of its rights, title and interest in and to the Mark, including the goodwill of the business symbolized thereby.
3. This Assignment shall be binding upon Assignor, Assignor's successors and assigns, and upon all others acting by, through, with or under Assignor's direction or control, and all those in privity therewith.
