THIS AGREEMENT is dated 8 April 2015

PARTIES

- 1 **NUJIRA LIMITED** a company incorporated in England and Wales with company number 4569647 whose registered office is at Building 1010, Cambourne Business Park, Cambourne, Cambridge, CB23 6DP (the "**Assignor**"); and
- 2 **OPENET ALLIANCE LIMITED** a company limited by guarantee and incorporated in England and Wales with company number 7493582 whose registered office is at St. John's Innovation Centre, Cowley Road, Cambridge, CB4 0WS the "**Assignee**").

BACKGROUND

- 1 The Assignor is the proprietor of the trade marks listed in the Schedule to this Deed (the "**Trade Marks**").
- 2 The Assignee has agreed to pay the registration costs of the Trade Marks in the sum of GBP £1,000 (One Thousand Pounds) (the "**Registration Costs**").
- 3 In consideration for payment of the Registration Costs, the Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out in this agreement.

AGREED TERMS

1 ASSIGNMENT

- 1.1 In consideration for payment of the Registration Costs, the Assignor hereby assigns to the Assignee absolutely with full title guarantee all its right, title and interest in and to the Trade Marks, including:
 - 1.1.1 all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Trade Marks are registered or used; and
 - 1.1.2 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from

ownership, of the Trade Marks (or either of them) whether occurring before, on or after the date of this agreement.

2 VAT

All payments made by the Assignee under this agreement are exclusive of VAT. If any such payment constitutes the whole or any part of the consideration for a taxable or deemed taxable supply by the Assignor, the Assignee shall increase that payment by an amount equal to the VAT which is chargeable in respect of the taxable or deemed taxable supply, provided that the Assignor shall have delivered a VAT invoice in respect of such VAT to the Assignee.

3 ENTIRE AGREEMENT

3.1 This agreement constitutes the entire agreement between the parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.

3.2 Each party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this agreement. Each party agrees that it shall have no claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this agreement.

4 COUNTERPARTS

This agreement may be executed in any number of counterparts, each of which when executed shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.

5 GOVERNING LAW AND JURISDICTION

5.1 This agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England.

5.2 The parties irrevocably agree that the courts of England shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).

THIS AGREEMENT has been entered into on the date stated at the beginning of it.




