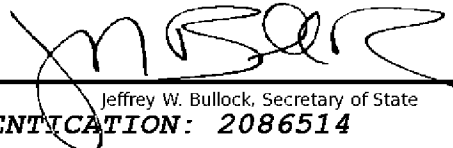

SECOND: Article I of the Corporation's Certificate of Incorporation is hereby amended in its entirety to read as follows:

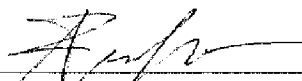
"1. Name. The name of the Corporation is Freestyle Solutions Inc."
