TRADEMARK ASSIGNMENT

WHEREAS, NSL holds the entire right, title, and interest in and to the trademark Tempus as used within the orthopedic industry, including U.S. Trademark Registration No. 4,353,896 (collectively, the "Mark"); and

WHEREAS, NSL wishes to assign to Buyer all right, title and interest in and to the Mark, together with all common law rights and the goodwill established through the use of and symbolized by the Mark, and Buyer desires to secure the entire right, title and interest in and to the Mark.

NOW, THEREFORE, be it known by all whom it may concern, that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

1. NSL hereby assigns, transfers and sets over to Buyer, its successors and assigns, and Buyer hereby accepts, the entire right, title and interest, whether statutory or at common law, in and to the Mark, together with the goodwill of the business identified through the use of and symbolized by the Mark, including the entire right to sue for and collect for Buyer's sole benefit all damages for any past infringement of the Mark.
2. NSL hereby agrees, without further consideration and without expense to the Buyer, to execute all papers and to perform all other acts which the Buyer may reasonably request to perfect this assignment and render it fully effective.
3. This Trademark Assignment shall be governed by, and construed in accordance with the laws of the State of New York.
4. This Trademark Assignment may be executed and delivered (including electronically) in one or more counterparts, and by the parties in separate counterparts, each of which when executed shall be deemed to be an original, but when taken together shall constitute one and the same agreement.

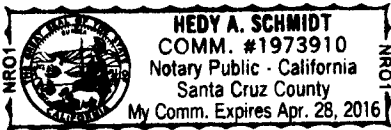
