TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of March 30, 2015 ("Effective Date"), by **VECTOR TRADING (CAYMAN), LP**, an exempted limited partnership organized under the laws of the Cayman Islands ("Vector"), in its capacity as Lender, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, "Grantee"), in favor of **SABA SOFTWARE, INC.**, a Delaware corporation ("Saba"), and **HUMANCONCEPTS, LLC**, a California limited liability company ("HumanConcepts"; Saba and HumanConcepts, each a "Grantor" and collectively, the "Grantors").

WHEREAS, reference is made to that certain Credit Agreement, dated as of July 5, 2013 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among Grantee, Saba, Hal Acquisition Sub Inc., and HumanConcepts;

WHEREAS, pursuant to the terms and conditions of (1) that certain Second Lien Borrower Trademark Security Agreement, dated as of July 5, 2013, by and among Saba and Grantee, which was recorded with the United States Patent and Trademark Office on July 8, 2013 at Reel 5065, Frame 0001, and (2) that certain Second Lien Subsidiary Guarantor Trademark Security Agreement dated as of July 5, 2013, by and among HumanConcepts and Grantee, which was recorded with the United States Patent and Trademark Office on July 8, 2013 at Reel 5065, Frame 0009, (the documents set forth in items (1) through (2) above, as amended, restated, supplemented, or otherwise modified and in effect from time to time, the "Second Lien Trademark Security Agreement"), the Grantors granted to Grantee a continuing second priority security interest in all of the Grantors' right, title and interest in and to the Collateral (as such term is defined in the Second Lien Trademark Security Agreement); and

WHEREAS, Grantee now desires to release its continuing second priority security interest in the Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

- 1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its continuing second priority security interest in the Collateral granted pursuant to the Second Lien Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Grantee in the Collateral pursuant to the Second Lien Trademark Security Agreement.
- 2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors' expense, as may be reasonably necessary to effect the release of the continuing second priority security interest in the Collateral contemplated hereby.
