**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK  
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of March 30, 2015 (“Effective Date”), by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association (“WFB”), in its capacity as Lender and as agent for the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, “Grantee”), in favor of **SABA SOFTWARE, INC.**, a Delaware corporation (“Saba”), **HAL ACQUISITION SUB INC.**, a Delaware corporation (“Hal Acquisition”), and **HUMANCONCEPTS, LLC**, a California limited liability company (“HumanConcepts”; Saba, Hal Acquisition, and HumanConcepts, each a “Grantor” and collectively, the “Grantors”).

**WHEREAS**, reference is made to that certain Amended and Restated Credit Agreement, dated as of June 27, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among Grantee, Saba, Hal Acquisition, and HumanConcepts;

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of July 5, 2013, by and among Grantors and Grantee, which was recorded with the United States Patent and Trademark Office on July 5, 2013 at Reel 005064, Frame 0754, as amended, restated, supplemented, or otherwise modified and in effect from time to time, the “Trademark Security Agreement”), the Grantors granted to Grantee a security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

**WHEREAS**, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:



Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors’ expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
