**TRADEMARK SECURITY AGREEMENT (TRADEMARKS, TRADEMARK REGISTRATIONS,  
TRADEMARK APPLICATIONS AND TRADEMARK LICENSES)**

March 17, 2015

WHEREAS, Lions Gate Entertainment Corp. (the "Borrower"), and the other Persons listed on the signature pages hereof (the Borrower and the other Persons being collectively referred to herein as the "Grantors", and individually as a "Grantor"), now own or hold and may hereafter adopt, acquire or hold Trademarks (defined as all of the following: all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade dress, logos, other source of business identifiers and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof or similar property rights, and all applications in connection therewith, including, without limitation, the registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof listed on Schedule A annexed hereto, and all reissues, extensions or renewals thereof), as such Schedule may be amended from time to time by the addition of Trademarks subsequently registered or otherwise adopted or acquired;

WHEREAS, the Grantors, JPMorgan Chase Bank, N.A. (the "Administrative Agent"), as administrative agent for the banks and other financial institutions or entities (the "Lenders") from time to time parties thereto, and the other parties set forth therein have entered into a Second Lien Credit and Guarantee Agreement dated as of the date hereof (as it may be amended or modified from time to time, the "Credit Agreement");

WHEREAS, the Grantors and the Administrative Agent have entered into a Pledge and Security Agreement, dated as of the date hereof (as it may be amended or modified from time to time, the "Security Agreement"), to secure the payment and performance of the Secured Obligations (capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement);

WHEREAS, each Grantor is entering into this Trademark Security Agreement in order to induce the Lenders to enter into and extend credit to the Borrower under the Credit Agreement and to secure the Secured Obligations;

WHEREAS, the Grantors have entered into an Intercreditor Agreement dated as of October 21, 2009 (as it may be amended, modified or supplemented from time to time, the "First Lien Intercreditor Agreement") with JPMorgan Chase Bank, N.A., as administrative agent (the "First Lien Administrative Agent") for the First Priority Secured Parties (as defined therein) and the Administrative Agent; and

WHEREAS, in addition, the Grantors have entered into an Intercreditor Agreement dated as of July 19, 2013 (as it may be amended or modified from time to time, the "Second Lien Intercreditor Agreement") with U.S. Bank National Association, as collateral agent (the "Trustee") for the 2018 Second Priority Notes and the Administrative Agent;

NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

Each of the Grantors do hereby grant to the Administrative Agent for the benefit of the Secured Parties, as security for the Secured Obligations, a continuing security interest in all of the Grantors' right, title and interest in, to and under the following (all of the following items or types of property being collectively referred to herein as the "Trademark Collateral"), wherever located or situated and whether now owned, presently existing or hereafter acquired or created:

- (a) each Trademark and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including, without limitation, each Trademark referred to in Schedule A annexed hereto, and all rights to sue for past, present, and future infringements thereof;
- (b) any and all Trademark licensing agreements or similar arrangements in and to such Grantor's Trademark, all income, royalties, damages, claims, and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages and payments for past, present and future breaches thereof, and all rights to sue for past, present, and future breaches thereof.

This security interest is granted in furtherance, and not in limitation, of the security interests granted to the Administrative Agent for the benefit of the Secured Parties pursuant to the Security Agreement. Each Grantor and the Administrative Agent hereby further acknowledges and affirms that the rights and remedies of the Administrative Agent for the benefit of the Secured Parties, with respect to the security interest made and granted hereby, are more fully set forth in the Security Agreement and are subject to the limitations (including certain rights of quiet enjoyment in favor of licenses) set forth therein, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

This Trademark Security Agreement is made for collateral purposes only. At such time as all Secured Obligations have been indefeasibly fully paid and performed, the Administrative Agent (on behalf of the Secured Parties) shall execute and deliver to the Grantors, at the Grantors' expense, without representation, warranty or recourse, all releases and reassignments, termination statements and other instruments as may be necessary or proper to terminate the security interest of the Administrative Agent (for the benefit of the Secured Parties) in the Trademark Collateral, subject to any disposition thereof that may have been made by the Administrative Agent pursuant to the terms hereof or of the Security Agreement.

Subject to the terms and conditions of the Security Agreement, the Administrative Agent (on behalf of the Secured Parties) agrees that there will be no assignment of the Trademark Collateral, other than the security interest described herein, unless and until there shall occur and be continuing an Event of Default and the Administrative Agent gives written notice to the Grantors of its intention to enforce its rights against any of the Trademark Collateral.

So long as no Event of Default shall have occurred and be continuing, and subject always to the various provisions of the Security Agreement and the other Fundamental Documents to which it is a party, each of the Grantors may use, license and exploit the Trademark Collateral in any lawful manner permitted under the Security Agreement and the other Fundamental Documents.

**THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH, AND GOVERNED BY, THE LAWS OF THE STATE OF NEW YORK**

**APPLICABLE TO CONTRACTS MADE AND TO BE PERFORMED WHOLLY WITHIN THE STATE OF NEW YORK.**

In the event of any conflict between this Trademark Security Agreement, on the one hand, and the First Lien Intercreditor Agreement, the Second Lien Intercreditor Agreement or any Additional Intercreditor Agreement, on the other hand, the First Lien Intercreditor Agreement, the Second Lien Intercreditor Agreement or such Additional Intercreditor Agreement, as applicable, shall govern. The lien created by this Trademark Security Agreement on the property described herein is (i) junior and subordinate to the lien on such property created by any mortgage, deed of trust or similar instrument now or hereafter granted to the First Lien Administrative Agent, the holders of First Priority Liens (as defined in the First Lien Intercreditor Agreement) and each of their successors and assigns in such property, in accordance with the provisions of the First Lien Intercreditor Agreement and any applicable Additional Intercreditor Agreements and (ii) *pari passu* to the lien on such property created by any mortgage, deed of trust or similar instrument now or hereafter granted to the Trustee and the holders of the 2018 Second Priority Notes and each of their successors and assigns in such property, in accordance with the provisions of the Second Lien Intercreditor Agreement.

In the event of any conflict between this Trademark Security Agreement, on the one hand, and the Security Agreement, on the other hand, the Security Agreement shall govern.


