WHEREAS, the Company is seeking to increase its credit extension pursuant to the Factoring Agreement, and the Company is now granting to the Factor a security interest in the Marks, together with the good will of the business symbolized by the Marks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Company does hereby grant to the Factor a security interest in and to the Marks, together with the good will of the business symbolized by the Marks (collectively, the "Collateral"), which security interest shall secure all the Obligations as defined in the Factoring Agreement and in accordance with the terms and provisions thereof.


The Company expressly acknowledges and affirms that the rights and remedies of the Factor with respect to the security interest granted hereby are more fully set forth in the Factoring Agreement.

the appropriate termination statements, releases and other documents reasonably requested by you to evidence such termination and authorize the filing of any such appropriate termination statement, release or other document to terminate such security interests.


