Assignor warrants that it is the legal owner of all right, title and interest in the Trademarks, that the Trademarks have not been otherwise previously pledged, assigned or encumbered and that this Assignment does not infringe the rights of any person. Assignor agrees to cooperate with Assignee and to execute and deliver all papers, instruments and assignments as may be necessary to vest all right, title and interest in and to the Trademarks, including, without limitation, recordation of the assignment in the United States Patent and Trademark Office.
