TRANSFER STATEMENT PURSUANT TO SECTION 9619 OF UNIFORM COMMERCIAL CODE

DATED February 15, 2013

- Secured Obligations. TriplePoint Capital LLC, a Delaware limited liability company ("TPC"), and Glacier Bay, Inc., a Delaware corporation ("Debtor"), entered into that certain Plain English Growth Capital Loan and Security Agreement, dated April 14, 2010 (as may have been amended, restated or modified from time to time, the "TPC Loan Agreement"). Silicon Valley Bank, a California chartered bank ("SVB" and, together with TPC, "Secured Parties"), and Debtor entered into that certain Loan and Security Agreement, dated December 22, 2008 (as may have been amended, restated or modified from time to time, the "SVB Loan Agreement"). The TPC Loan Agreement, the SVB Loan Agreement and all other agreements, amendments, documents, financing statements and instruments executed in connection therewith, respectively, shall be collectively referred to as the "Credit Documents." To secure performance of all obligations owing to Secured Parties, respectively, under the Credit Documents, Debtor granted to Secured Parties, respectively, a security interest in substantially all of Debtor's assets, including, without limitation, all patents, patent applications, trademarks and trademark applications filed with the United States Patent and Trademark Office in connection with the assets pertaining to the development, manufacturing, sales or distribution of Debtor's load following power generation products, including, without limitation, those more specifically identified on Exhibit A attached hereto (the "Transferred Patents and Trademarks").
- 2. <u>Default.</u> Debtor defaulted on its obligations to Secured Parties, respectively, with respect to the Credit Documents.
- 3. <u>Exercise of Post-Default Remedies</u>. Secured Parties have jointly exercised their respective postdefault remedies with respect to, among other things, the Transferred Patents and Trademarks, by a disposition thereof pursuant to Section 9610 of the California Uniform Commercial Code (as from time to time amended, the "<u>UCC</u>") to Greenport Inc., a New Jersey corporation ("<u>Transferee</u>") (such disposition, the "Foreclosure Sale").
- 4. <u>Transferee's Rights in the Transferred Patents and Trademarks</u>. As a result of the Foreclosure Sale, Transferee has acquired all of Debtor's rights, titles and interests in, among other things, the Transferred Patents and Trademarks.
- 5. <u>Discharge of Security Interests of Secured Parties</u>. Upon the closing of the Foreclosure Sale, as provided by Section 9617 of the UCC, the disposition of the Transferred Patents and Trademarks shall discharge the security interests of Secured Parties and any subordinate security interest or other subordinate lien in and to the Transferred Patents and Trademarks.
