RELEASE OF SECURITY INTEREST
IN PATENTS, TRADEMARKS AND COPYRIGHTS

This RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS (the "Release"), dated as of December 31, 2014 (this "Release"), is made by FIRST NIAGARA BANK, N.A. as administrative agent (the "Administrative Agent"), in favor of B.J. ALAN COMPANY, an Ohio corporation (the "Borrower"), and each of the other Pledgors. Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Credit Agreement and/or the Patent, Trademark and Copyright Security Agreement (as those terms are defined below).

WHEREAS, the Borrower is party to a Credit Agreement dated as of March 20, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Pledgors and the Administrative Agent;

WHEREAS, the Borrower is party to a Patent, Trademark and Copyright Security Agreement dated as of March 20, 2012 (the "Patent, Trademark and Copyright Security Agreement"), among the Pledgors and the Administrative Agent;

WHEREAS, pursuant to the Patent, Trademark and Copyright Security Agreement, the Pledgors pledged to the Administrative Agent for the benefit of the Lenders, a security interest (referred to in this Release as the "Security Interest") in the Pledgors' present and future right, title and interest in and to certain patents, trademarks and/or copyrights, including those listed on Schedule A hereto, all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the goodwill of the business to which any of the patents, trademarks and copyrights relate (the "Patents, Trademarks and Copyrights").

WHEREAS, the Debt has been paid and performed in full and the Administrative Agent has agreed to terminate and release all of its and the Lenders' right, title and interest in or to the Patents, Trademarks and Copyrights, including the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Administrative Agent, on behalf of itself and the Lenders, hereby (i) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges its and the Security Interest and any of its and the Lenders' right, title and interest in or to the Patents, Trademarks and Copyrights, whether granted pursuant to the Patent, Trademark and Copyright Security Agreement or any other agreement or document delivered in connection with the Credit Agreement or the Patent, Trademark and Copyright Security Agreement, (ii) terminates the Patent, Trademark and Copyright Security Agreement and any other agreement or document

delivered in connection with the Patent, Trademark and Copyright Security Agreement and (iii) reassigns to the Pledgors any and all right, title and interest (if any) that the Administrative Agent or any of the Lenders may have in or to any of the Patents, Trademarks and Copyrights (including any goodwill associated therewith), together with all rights to sue or to recover, at law or in equity, for any past, present or future infringement, dilution, misappropriation or other violation of the Patents, Trademarks and Copyrights and all rights to any income, royalties, and proceeds arising from or with respect thereto.


2. Authorization to Record. The Administrative Agent authorizes and requests that the United States Patent and Trademark Office (the "USPTO"), the U.S. Copyright Office and any applicable government officer record this Release. This Release may, in particular, be recorded with the USPTO to reflect the release of the Security Interest in U.S. trademarks recorded with the USPTO on April 24, 2012 at Trademark Reel 4763, Frame 0132.

3. Further Assurances. The Administrative Agent agrees to cooperate with the Pledgors and to provide the Pledgors with such information and additional authorization and to execute and deliver to Pledgors such additional instruments and to take such action, in each case, at the sole cost and expense of the Pledgors and as the Pledgors may reasonably request or as may be reasonably necessary to effect and record the release of the Security Interest.

4. Governing Law. This Release shall be construed in accordance with and governed by the laws of the Commonwealth of Pennsylvania.
