TRADEMARK AND COPYRIGHT ACQUISITION AND ASSIGNMENT

This Trademark and Copyright Acquisition and Assignment Agreement (the "Agreement") is entered into between Jeffrey Wade, having a place of business at 248 Village Blvd. Suite 3204; Tequesta, Florida 33469 ("Wade") and CCA Global Partners, Inc., a Delaware corporation having a place of business at 4301 Earth City Expressway, Earth City, Missouri 63045 ("CCA Global"), and is effective on the date of the last signature ("Effective Date").

WHEREAS, BioShield Services, LLC ("Bioshield") has adopted and used in its business the trademark IASQ for educational services and certification services related to the field of indoor air and surface quality (the "Mark"), and is the record owner of U.S. Trademark Registration No. 3,701,643, issued October 27, 2009, for *education services, namely, providing live and on-line courses, classes, seminars, workshops in the field of Indoor Air and Surface Quality*, covering the Mark (the "Registration");

WHEREAS, Wade has filed a Combined Declaration of Use and Incontestability Under Sections 8 and 15 of the Trademark Act (15 U.S.C. §§1058, 1065) in connection with U.S. Trademark Registration No. 3,701,643, to establish the incontestability status of the Registration, and the U.S. Patent and Trademark Office has issued a Notice of Acceptance under Section 8 and a Notice of Acknowledgment under Section 15, a copy of which is attached hereto as Exhibit A;

WHEREAS, BioShield has developed, or has had developed, and has used certain educational and certification materials in connection with providing its education and certification services under the Mark (the "Materials");

WHEREAS, Bioshield has assigned all rights to the trademarks and other intellectual property to Jeffrey Wade, an individual;

WHEREAS, CCA Global is desirous of acquiring all interest in and to the Mark and the above-referenced Registration therefor; and

WHEREAS, CCA Global is desirous of acquiring the Materials and all right, title and interest in and to all copyrights covering the Materials.

NOW, THEREFORE, to all whom it may concern, be it known that in consideration of the promises and mutual covenants herein contained, the sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Consideration. In consideration for the terms and conditions set forth herein,

2. Transfer of Trademark Rights. Jeffrey Wade hereby assigns, sells and transfers to CCA Global any and all of Wade's rights, title and interest in and to the Mark (whether registered or in common law anywhere in the world) and the U.S. Registration No. 3,701,643 therefor, as well as any and all goodwill in connection with the Mark, as well as all of Wade's

right, title and interest in and to any and all claims and demands it may have, at law or in equity, for past infringement by others of the Mark. Wade further agrees to take all steps necessary to execute any and all documentation needed to assign U.S. Registration No. 3,701,643 to CCA Global.
