THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination"), is dated as of April 7, 2015, and made by JPMorgan Chase Bank, N.A., a national banking association, as administrative agent, P.O. Box 2558, Houston, Texas 77252 (the "Agent") to Consolidated Vision Group, Inc., a Delaware corporation, (the "Grantor").

WHEREAS, certain security interests (the "Interests") were granted by the Grantor to the Agent in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Assignment Division of the United States Patent and Trademark Office on November 24, 2010, at Reel 4421 and Frame 0689;

WHEREAS, the Agent now desires to terminate and release the Interests; and

NOW, THEREFORE, for good and valuable consideration, the Agent hereby states as follows:


1. Definitions. The term "Trademarks", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. Capitalized terms used herein without definition are used as defined in the Guarantee and Collateral Agreement, dated as of November 23, 2010, made by, *inter alios*, the Grantor in favor of the Agent.

2. Release of Security Interest. The Agent hereby terminates the Interests and terminates, releases and discharges its interest in the Trademarks.
