

Seller hereby subrogates in favor of Buyer and its successors, assigns and legal representatives its right to sue for past infringements and collect same for the sole use and enjoyment of Buyer and its successors, assigns and legal representatives.

Seller further authorizes the Director of the United States Patent & Trademark Office, and any official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of Buyer, its successors, legal representatives and assigns in accordance with the terms of this instrument.
