### ASSIGNMENT OF TRADEMARK RIGHTS

This Agreement is by and between

**RENT A TOLL, LTD.**, a Texas limited partnership, with offices at 110 W Louisiana Ave., Suite 312, Midland, Texas 79701 ("Assignor"), the owner of the Trademarks and related rights described below; and

ATS TOLLING LLC, a Delaware limited liability company, with offices at 1330 West Southern Avenu Tempe, A2 85201"Assignee") which desires to acquire all right, title and interest in the Trademarks and the related rights described below.

- A. Assignor and the Assignee are parties to that certain Asset Purchase Agreement, dated as of June 23, 2014 (the "Asset Purchase Agreement"), pursuant to which the Assignee acquired certain assets of the Assignor (as defined in the Asset Purchase Agreement).
- B. Pursuant to the Asset Purchase Agreement and the accompanying Bill of Sale, the Assignor assigned to the Assignee, effective as of the Effective Date, all of Assignor's right, title and interest in, to and under its trademarks and service marks.
- C. This Assignment of Trademark Rights ("Assignment") is intended by the parties to be a confirmatory assignment for purposes of recording the ownership transfer with the U.S. Patent and Trademark Office.

NOW THEREFORE, in consideration of the premises and mutual agreements set forth in the Asset Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. Capitalized terms used herein without definitions shall have the respective meanings set forth in the Asset Purchase Agreement.
- 2. Assignor hereby assigns to Assignee the entire right, title and interest in and to all domestic and foreign (i) registrations of trademarks, service marks, logos, corporate names, domain names, designs, trade names and other trade rights of Assignor, including but not limited to those set forth on Schedules A and B hereto, (ii) pending applications by Assignor for any such registrations, (iii) rights of Assignor to other trademarks, trade dress, service marks, logos, corporate names, domain names, designs, trade names and other trade rights, whether or not registered, including but not limited to those set forth on Schedule C hereto (collectively the "Trademarks"), together with the goodwill of the business associated with the Trademarks.
- 3. The above assignment of Trademarks includes all rights of action, powers and benefits in and to the Trademarks, due or accrued, including the right to sue for and recover in Assignee's own name and that of its successors and assigns and other legal representatives all remedies of every nature, including, without limitation, rights to injunctive relief, damages, profits, costs and attorney fees, arising out of past infringement of the Trademarks, and injury to the related goodwill.

Assignor further agrees to execute any and all documents and to do all other things reasonably requested by Assignee in order to make all necessary or desirable filings and recordations before relevant governmental authorities and to vest more fully in Assignee any and all ownership rights in the Trademarks hereby transferred.
- 5. In the event of a conflict between the terms and conditions of this Assignment and the terms and conditions of the Asset Purchase Agreement, the terms and conditions of the Asset Purchase Agreement shall govern, supersede and prevail. Notwithstanding anything to the contrary, nothing herein is intended to, nor shall it, extend, amplify or otherwise alter the representations, warranties, covenants and obligations of the parties contained in the Asset Purchase Agreement or the survival thereof.
- 6. This Assignment may be executed in any number of counterparts with the same effect as if the signatures thereto were upon one instrument.




