TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

This Termination and Release of Grant of Security Interest in United States Trademarks (this "Release"), dated this 7th day of April, 2015, is by KEYBANK NATIONAL ASSOCIATION ("KeyBank").

A. WHEREAS, WORM'S WAY, INC. ("Grantor") granted KeyBank a security interest in its trademarks listed on Schedule A (collectively the "Trademarks");

2) KeyBank hereby authorizes Grantor (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish KeyBank's rights and interest in the Trademarks.

3) This Release is governed by the law of the State of Indiana, excluding its choice of law principles to the contrary.

4) This Release shall be binding upon KeyBank and its successors and assigns and inures to the benefit of Grantor and its successors and assigns.
