RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, pursuant to that certain Second Amended and Restated Intellectual Property Security Agreement, dated as of August 14, 2006, recorded in the United States Patent and Trademark Office at Reel 3403, Frame 0684 (the "Intellectual Property Security Agreement"), E2OPEN, INC., a Delaware corporation ("Releasee"), granted and pledged to BRIDGE BANK, NATIONAL ASSOCIATION ("Releasor"), a security interest in all right, title and interest of Releasee in any of the following, whether then existing or thereafter acquired or created in any and all of the following property (collectively, the "Intellectual Property Collateral"):

- a) copyright rights, copyright applications, copyright registrations and like protections in each work or authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, then or thereafter existing, created, acquired or held (collectively, the "Copyrights"), including the Copyrights described in Schedule A;
- b) trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Borrower connected with and symbolized by such trademarks (collectively, the "Trademarks"), including the Trademarks described in Schedule B;
- c) patents, patent applications and like protections including without limitation improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same (collectively, the "Patents"), including the Patents described in Schedule C;
- d) mask work or similar rights available for the protection of semiconductor chips or other products (collectively, the "Mask Works");
- e) trade secrets, and any and all intellectual property rights in computer software and computer software products;
- f) design rights;
- g) claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;
- h) licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works, and all license fees and royalties arising from such use to the extent permitted by such license or rights;
- i) amendments, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works;
- j) proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Intellectual Property Security Agreement to confirm the release, relinquishment and discharge of its continuing first priority security interest in the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement.

2. Release of Security Interest. Releasor hereby, without any representation and warranty and without any recourse to Releasor, releases, relinquishes and discharges its security interest in the Intellectual Property Collateral.
