NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of February 13, 2015, by VISIONAPP GMBH ("Vision") and Allen Systems Group, Inc. ("ASG," and together with Vision, the "Grantors"), in favor of Wilmington Trust, National Association, as agent for certain lenders (the "Successor Agent") (this "Notice").

WHEREAS, the Grantors hold all right, title and interest in and to the trademarks and trademark applications listed on the annexed Schedule A, which trademarks are registered in and trademark applications are filed in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, ASG, Successor Agent, the lenders party thereto and TPG Allison Agent, LLC (the "Original Agent") have entered into a Successor Administrative Agent Agreement, dated December 22, 2014, pursuant to which the Original Agent has assigned to the Successor Agent all of its rights, interests, powers, privileges and duties under that certain Credit Agreement, dated as of December 14, 2012 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Domestic Credit Agreement");

WHEREAS, Atempo SAS, Successor Agent, Natixis, New York Branch, the subparticipants party thereto and the Original Agent have entered into a Successor Administrative Agent Agreement, dated December 22, 2014, pursuant to which the Original Agent has assigned to the Successor Agent all of its rights, interests, powers, privileges and duties under that certain Credit Agreement, dated as of December 14, 2012 (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Foreign Credit Agreement");

WHEREAS, (i) ASG had granted to the Original Agent for the benefit of the lenders under the Domestic Credit Agreement and (ii) Vision had granted to the Original Agent for the benefit of the lenders under the Foreign Credit Agreement, in each case, a continuing security interest in all right, title and interest of such Grantor in, to and under the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof to secure the payment, performance and observance of certain obligations;

WHEREAS, the Grantors and the Successor Agent wish to record evidence of the continuing security interest now held by the Successor Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors do hereby pledge, convey, sell, transfer and set over unto the Successor Agent and grant to the Successor Agent for the benefit of the lenders a continuing security interest in the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof to secure the prompt payment, performance and for the benefit of the lenders observance of certain obligations.
