**DECLARATION OF FREDERICK H. COLEN
REGARDING RECORDAL OF INCORRECT TRADEMARK
REGISTRATION NOS. 2,096,381; 2,324,211; AND 2,332,136 AT REEL 005236, FRAME
0641 AND REEL 005237. FRAME 0533**

I, Frederick H. Colen, declare and say as follows:


1. I am an attorney admitted to the Pennsylvania Bar and have been so admitted since 1975. I am in good standing with the Pennsylvania Bar.
2. I am Counsel with the law firm Reed Smith LLP and am based in Pittsburgh, Pennsylvania. I have been with Reed Smith since 1979.
3. My daily practice focuses on intellectual property transaction and litigation matters, and includes registering trademarks/service marks and filing associated documents with the United States Patent and Trademark Office (“USPTO”).
4. I have represented Mine Safety Appliances Company (a Pennsylvania corporation) in connection with its trademark and other intellectual property matters for more than 20 years.
5. Effective March 7, 2014, Mine Safety Appliances Company underwent a corporate reorganization in which (in part) Mine Safety Appliances Company was merged into Mine Safety Appliances Company, LLC (a Pennsylvania limited liability company), with Mine Safety Appliances Company, LLC being the surviving entity.
6. As part of that corporate reorganization, MSA Technology, LLC (a Pennsylvania limited liability company) was established to own the patents, trademarks and other intellectual property previously owned by Mine Safety Appliances Company.
7. As part of the corporate reorganization, the patents, trademarks and other intellectual property of Mine Safety Appliances Company were first transferred by merger from Mine Safety Appliances Company to Mine Safety Appliances Company, LLC, and then transferred by assignment from Mine Safety Appliances Company, LLC to MSA Technology, LLC, both such transfers effective as of March 7, 2014.
8. The transfer of the trademarks/service marks from Mine Safety Appliances Company to Mine Safety Appliances Company, LLC was first filed with, and recorded by, the Assignment Branch of the USPTO at Reel 005236, Frame 0641, on March 13, 2014.
9. The assignment of the trademarks/service marks from Mine Safety Appliances Company, LLC to MSA Technology, LLC was next filed with, and recorded by, the Assignment Branch of the USPTO at Reel 005237, Frame 0533, on March 14, 2014.
10. The list of trademarks/service marks recorded at both Reel 005236, Frame 0641 and Reel 005237, Frame 0533 inadvertently and mistakenly included three registrations – Registration Nos. 2,096,381; 2,324,211; and 2,332,136 – of an unrelated third party, The Cairns

Trademark Trust (a trust created under the laws of New Jersey); registrations and marks under which Mine Safety Appliances Company was the exclusive licensee with regard to fire helmets.

11. The Corrective Assignments that are being filed contemporaneously with this Declaration are being filed to correct the inadvertent and erroneous transfer and assignment of the three registrations of The Cairns Trademark Trust -- Registration Nos. 2,096,381; 2,324,211; and 2,332,136 -- first to Mine Safety Appliances Company, LLC and then to MSA Technology, LLC, since Mine Safety Appliances Company (i) never owned these three registrations, all of which were (and continue to be) owned by The Cairns Trademark Trust; and (ii) therefore could not legally transfer or assign these three registrations and their associated good will.

12. The Corrective Assignments that are being contemporaneously filed with this Declaration are being filed to correct the records of the USPTO to properly indicate that the three registrations of The Cairns Trademark Trust -- Registration Nos. 2,096,381; 2,324,211; and 2,332,136 -- are, and remain, owned by The Cairns Trademark Trust.

I, Frederick H. Colen, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements and the like may jeopardize the validity of the Corrective Assignments referenced above, declare that I am properly authorized to execute this Declaration and that all statements made herein of my own knowledge are true and correct, and all statements made on information and belief are believed to be true.
