## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated March 31, 2015 by Fifth Third Bank, an Ohio banking corporation ("*Fifth Third*"), with its mailing address at 1445 Ross Avenue, Suite 4900, Dallas, Texas 75202, acting as agent hereunder for the Secured Creditors as defined in the Agreement referred to below (Fifth Third acting as such agent being hereinafter referred to as the "*Agent*");

### WITNESSETH:

WHEREAS, AGM Automotive, LLC, a Delaware limited liability company ("*Debtor*"), with its mailing address at 1708 Northwood Drive, Troy, Michigan 48084, and Agent were parties to that certain Amended and Restated Trademark Security Agreement dated as of January 31, 2014 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on March 6, 2014, at Reel 5232, Frame 0083 (such Amended and Restated Trademark Security Agreement entered into by such parties to amend and restate that certain Trademark Security Agreement dated April 23, 2013, between Debtor and Fifth Third which was recorded in the United States Patent and Trademark Office on July 1, 2013, at Reel 5061, Frame 0590, being hereinafter referred to as the "*Agreement*"), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, trademark applications and trademark licenses listed on Schedule I attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, Debtor has requested that Agent release its security interests in the Trademark Property and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, trademark application, and trademark license listed on Schedule I hereto, including:


- (a) all of Debtor's right, title and interest in and to all of its now or in the future owned or existing trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications, including each mark, registration, and application listed on Schedule I attached hereto and made a part hereof (the property in this item (a) being collectively, the "*Trademarks*");
- (b) all renewals of each of the Trademarks;
- (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all Trademarks, including damages and payments for past or future infringements of any and all Trademarks;
- (d) all rights to sue for past, present and future infringements of any and all Trademarks;
- (e) all rights corresponding to each of the Trademarks throughout the world;
- (f) all rights of Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark registrations and applications, including the licenses listed on Schedule I and the Trademark Licenses (as defined in the

Agreement); and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing.
