RELEASE OF TRADEMARK

This **RELEASE OF TRADEMARK**, dated as of April 20, 2015, is made by General Electric Capital Corporation ("Administrative Agent"), in favor of NxStage Medical, Inc. (the "Grantor") party to the Trademark Security Agreement (as defined below).

FURTHER, the Trademark Security Agreement remains (and, following the foregoing release in respect of the Released Trademark, shall remain) in full force and effect as among the Administrative Agent and Grantor and all liens and security interests granted by the Grantor in and to the Trademarks (other than the Released Trademark) shall remain in full force and effect.
