BILL OF SALE

Purchaser acknowledges that Purchaser has fully inspected the Transferred Property, and Purchaser accepts the Transferred Property in its present used and "as is" condition without any warranty (express or implied) including, but not limited to, any warranty of merchantability or fitness for a particular purpose. Purchaser accepts no liability arising out of the operation of CurbGames, LLC prior to the Effective Date. Purchaser agrees to indemnify, defend and hold harmless Seller and its officers, managers, directors, owners, employees, agents, attorneys, parents, subsidiaries, and affiliates of each of them from and against all claims, losses, liabilities, judgments, damages, costs, expenses, demands, suits (including but not limited to fees and expenses of attorneys, experts, consultants), and all other costs arising out of or related to, or alleged to arise out of or be related to the Transferred Property after the Effective Date.

Seller represents and warrants that all property conveyed in this Bill of Sale- listed in Exhibit A- is owned free and clear and unencumbered in any way. Seller further warrants that there are no outstanding claims, losses, liabilities, judgments, damages, costs, expenses, demands, suits (including but not limited to fees and expenses of attorneys, experts, consultants), and all other costs arising out of or related to the Transferred Property prior to the Effective Date. Seller also represents and warrants that CURBGAMES, LLC is a company in "good standing" with the State of Texas, city and county entities within the area in which it operates or has operated up and through the Effective Date. Further, Seller warrants that all taxes due and payable have been remitted and are current through the Effective Date. Seller agrees to furnish free and clear titles for each vehicle listed in Exhibit A. Purchaser shall be liable for the payment of any transfer, registration, documentary or sales tax associated with the Transferred Property and its pro-rata portion of any property tax associated with the Transferred Property for the 2015 calendar year as required by the state, city or county of governance that may become due or payable in connection with this Bill of Sale. Purchaser shall pay Seller for its pro-rata portion of any property tax for the 2015 calendar year within thirty (30) days of written demand from Seller.

Seller and Purchaser covenant and agree that Seller and Purchaser and such parties' respective successors and assigns (if any) shall execute, deliver and file, at the Purchaser's expense such other instruments of conveyance and transfer and take such other action as may be reasonably required to convey, transfer possession to and vest in Purchaser the Transferred Property, or that are likewise necessary to carry out the purposes of this Agreement.

This Bill of Sale shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflict of law principles. This Bill of Sale constitutes the entire agreement between the parties hereto pertaining to the subject matter hereof and supersedes all prior agreements, understandings, negotiations and discussions, whether oral or written, of the parties. No supplement, modification or waiver of this Bill of Sale shall be binding unless executed in writing by the party to be bound thereby. The failure of a party to exercise any right or remedy shall not be deemed or constitute a waiver of such right or remedy in the future. No waiver of any of the provisions of this Bill of Sale shall be deemed or shall constitute a waiver of any other provision hereof (regardless of whether similar), nor shall any such waiver constitute a continuing waiver unless otherwise expressly provided. This Bill of Sale may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. Signature pages delivered via fax or e-mail shall be deemed original.




