## **RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS**

April 10, 2015

**WHEREAS**, MUSICIAN'S FRIEND, INC., a Delaware corporation (the "**Grantor**") granted a security interest to BANK OF NEW YORK MELLON TRUST COMPANY, N.A., with offices at 400 South Hope Street, Suite 400, Los Angeles, California 90071 (the "**Notes Collateral Agent**") in and lien upon certain trademarks as set forth in that certain Notice of Security Interest in Trademarks dated April 2, 2014 by the Grantor in favor of the Notes Collateral Agent (the "**Trademark Notice**"), which was recorded in the United States Patent and Trademark Office (the "**PTO**") on April 3, 2014 at Reel 5251, Frame 0464; and

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, Notes Collateral Agent hereby:

1. Releases, fully discharges and reassigns to Grantor any and all liens, security interests, right, right of control, title and interest of Notes Collateral Agent pursuant to the Trademark Notice in the trademarks identified in **Schedule A**, all proceeds and products of the trademarks identified in **Schedule A**, all goodwill associated with any of the trademarks identified in **Schedule A**, and all causes of action for infringement of the trademarks identified in **Schedule A**, without recourse or representation or warranty, express or implied of any kind;

2. to the extent that Notes Collateral Agent has any remaining right or interest in Grantor's trademarks identified in **Schedule A**, Notes Collateral Agent hereby assigns and agrees to assign such remaining right or interest to Grantor; and

3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

Notwithstanding the foregoing, the Trademark Notice remains in full force and effect with respect to any and all Marks other than the trademarks identified on **Schedule A**.
