RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST

THIS RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST (this "Release") is given on April 22, 2015, by SUNTRUST BANK, as Administrative Agent (the "Secured Party"), to THE E.W.
