**RELEASE OF GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

This Release of Grant of Security Interest in United States Trademarks dated as of April 22, 2015 (the "Trademark Release") is conveyed in favor of the Assignors (as defined below) by **GENERAL ELECTRIC CAPITAL CORPORATION**, in its capacity as working capital agent for itself and the other lending institutions (in such capacity, the "Working Capital Agent") pursuant to the Amended and Restated Loan and Security Agreement dated as of November 15, 2012 (as amended, amended and restated, supplemented or otherwise in effect prior to the date hereof).

WHEREAS, Hancock Fabrics, Inc., a Delaware corporation, HF Merchandising, Inc., a Delaware corporation, Hancock Fabrics of MI, Inc., a Delaware corporation, Hancockfabrics.com, Inc., a Delaware corporation, Hancock Fabrics, LLC, a Delaware limited liability company, HF Enterprises, Inc., a Delaware corporation, and HF Resources, Inc., a Delaware corporation (collectively, the "Assignors") granted a security interest (the "Security Interest") in favor of the Working Capital Agent, in and to certain intellectual property held by the Assignors, including, without limitation, the trademarks and trademark applications listed on Schedule A attached hereto and made a part hereof (collectively, the "Trademarks"), and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as set forth in that certain (a) Trademark Collateral Assignment and Security Agreement dated as of August 1, 2008 (as amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Agreement") given by the Assignors in favor of the Working Capital Agent, which was recorded with the United States Patent and Trademark Office (the "USPTO") on August 4, 2008, at Reel 3828, Frame 0434; and (b) Notice of Grant of Security Interest in Trademarks dated as of November 15, 2012 (as amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Notice") given by the Assignors in favor of the Working Capital Agent, which was recorded with the USPTO on November 15, 2012, at Reel 4901, Frame 0599.

WHEREAS, the Working Capital Agent has agreed to terminate and release its Security Interest in all such Trademarks and as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Working Capital Agent hereby:

1. Releases the Security Interest and hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Security Interest;
2. Reassigns to the Assignors any and all liens, security interests, right, title and interest granted to the Working Capital Agent pursuant to the Trademark Agreement and Trademark Notice in the Trademarks identified on Schedule A and/or any goodwill associated with any of the Trademarks identified on Schedule A, without recourse or representation or warranty, express or implied, of any kind; and
3. Authorizes that the USPTO note and record the existence of the release hereby given.
