Attend.com, Inc. (hereinafter called the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: The name of the Corporation is Attend.com, Inc. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on June 12, 2013, under the name Attendware, Inc. On March 17, 2014, a First Certificate of Amendment of Certificate of Incorporation was filed with the Secretary of State to change the name of the Corporation from Attendware, Inc. to Attend.com, Inc. On May 15, 2014, a First Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware. On September 11, 2014, a Certificate of Amendment of the First Amended and Restated Certificate of Incorporation was filed with the Secretary of State. On January 16, 2015, a second Certificate of Amendment of the First Amended and Restated Certificate of Incorporation was filed with the Secretary of State.

SECOND: The First Amended and Restated Certificate of Incorporation, as amended and in effect, is hereby amended by deleting Article FIRST and replacing it in its entirety with:

"FIRST: The name of this corporation is Attend, Inc. (the "Corporation")."

THIRD: That the aforesaid amendment was duly adopted by the Board of Directors of the Corporation in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware and has been consented to in writing by the stockholders of the Corporation in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware.
