**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "Termination and Release") is granted as of April 21, 2015 by **Crystal Financial SBIC LP**, a Delaware limited partnership, in its capacity as agent for the Lender Group as described in the Credit Agreement described below (the "Agent"), in favor of **Hillerich & Bradsby, Co.**, a Kentucky corporation having an address at 800 W. Main Street, Louisville, Kentucky 40202 (the "Company").

WITNESSETH:

WHEREAS, the Company is a party with the Agent to a Credit Agreement dated as of June 27, 2014 (as amended, supplemented, extended, restated, or otherwise modified prior to the date hereof, the "Credit Agreement") pursuant to which the Agent agreed, among other things, to extend certain credit accommodations to Company under the terms and conditions set forth therein;

WHEREAS, pursuant to the Credit Agreement, the Company executed and delivered a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Security Agreement") granting the Agent a security interest in and lien on certain Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 30, 2014, at Reel 5312, Frame 0875, against certain Trademark Collateral identified on Schedule I hereto;

WHEREAS, the Company has satisfied all of the obligations under the Credit Agreement and has requested that the Agent terminate and release its security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. All capitalized terms used herein shall have the meaning ascribed to them in the Credit Agreement, unless otherwise defined in this Termination and Release.

2. Trademark Collateral. The term "Trademark Collateral," as used herein, shall mean all of Company's right, title, and interest in and to the following:

(a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule I;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and

(c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by Company against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under and Intellectual Property License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License.


3. Release of Security Interest. The Agent hereby terminates, releases and discharges its liens and security interests in the Trademark Collateral, including but not limited to the Trademark Collateral identified on Schedule I, together with all products and proceeds thereof, including without limitation, any claims by the Company against third parties for past, present, or future infringement of any Trademark.

4. Reassignment. The Agent hereby reassigns, grants, and conveys to the Company, without any representation, recourse or undertaking by the Agent, all of the Agent's right, title, and interest in and to the Trademark Collateral.

IN WITNESS WHEREOF, the undersigned has executed this Termination and Release by its duly authorized officer as of the date first above written.


