**ARTICLES OF RESTATEMENT AND AMENDMENT  
OF  
SENSINTEL, INC.**

**ARTICLE 1  
NAME**

The name of the corporation is Raytheon Sensintel, Inc. (the "Corporation").

**ARTICLE 2  
CORPORATE PURPOSE AND POWERS**

The purpose of the Corporation is to engage in any and all lawful business or activity for which a for-profit business corporation may be organized under the laws of the State of Arizona, as they may be amended from time to time.

**ARTICLE 3  
INITIAL CHARACTER OF BUSINESS**

The Corporation initially intends to provide engineering research and testing services.

**ARTICLE 4  
CAPITAL STOCK**

A. The total number of shares of stock which the Corporation shall have authority to issue shall be 1,000 shares of common stock, per value \$1.00 per share ("Common Stock"), which shall be the only voting shares.

B. Except as otherwise required by applicable law, each holder of Common Stock shall be entitled to one (1) vote for each share of Common Stock held by such holder.

**ARTICLE 5  
PLACE OF BUSINESS**

The address of the known place of business of the Corporation in the State of Arizona is 3292 E. Hemisphere Loop, Tucson, Arizona 85706.

**ARTICLE 6  
BOARD OF DIRECTORS**

The number of directors of the Corporation shall be fixed at one, which number may be increased or decreased pursuant to the By-Laws of the Corporation, but shall never be less than the minimum number permitted by Arizona statute now or hereafter in force. The sole director, who shall serve until the next annual meeting of shareholders or until his successor is duly elected and qualified, is Dana Ng, 870 Winter Street, Waltham, Massachusetts 02451.

**ARTICLE 7**  
**STATUTORY AGENT**
